Health and Sanitation: no report

Tax Gellecter: report accepted as read - there are 25 outstanding tax bills of which 13 have had liens placed on the property.

Auditers report: The books were audited by Mrs. Rese Miller and Mrs. Mary Maheney and found to be in order

Building Committee: Mr. Grever reports that Mr. Parker has come up with some idea regarding the building of the proposed clubhouse but because Mr. Parker was not present and Mr. Grever wasn't too well informed he did not feel at liberty to reveal to the people present just what this idea is.

Mr. Silva reported that the stickers for beach privileges for property owners had arrived and would be mailed present by to these people whose taxes are paid.

Mrs. Extracery reported as to why the idea of a building had not been voted upon by the people. It was noted that the idea of an open pavillion type of building had been voted upon and it was reported by Mr. Grever that because the Committee hasn't as yet come up with anything satisfactory, they did not actually, have anything for the people to vote upon.

Mrs. Jehnsen inquired why the stenes and stumps had not been removed and there was much discussion. The money had been appropriated and after much discussion it was decided by a metien which was made and seconded that \$200 would be taken from the General Fund for this purpose. Mr. Jehnsen take charge of this and see that this is done.

The prepsed Budget was accepted as read.

A metion was made by Mr. Lewry and seconded that 2-1/4 mil be used for the general fund and 3/4 mil be designated for the Building Fund.

The minutes of the previous meeting was read and accepted.

The treasurer's report was read and accepted.

The Picnic Committee Report was read by the chairman, Mrs. Gierula. The cost of the picnic was \$302.67. \$217.12 was made plus \$65.33 cash on hand giving a total of \$282.95 toward next years picnic.

Mr. Lowry of the Recreation Committee proposed the following, to the members of the Association:

- 1.) To impower the Executive Committee to discuss with the Selectman of the Town of Lebanon to have the town install storm sewers along Lake Williams Road. (This would prevent flooding and ruination of the beaches.)
- 2.) That \$5 be set aside for rubbish collection at the 3 beaches.
- 5.) That a bulletin board be placed near the entrance of Lake Williams Road, stating that Private Beaches are for property owners only. Fine - \$1.00 for each offense.
- 4.) That a bulletin board be installed at each of the three beaches and at the recreation area listing regulations and new events.
- 5.) That the following laws be enforced:
 - a. no discarding of glass clippings and dumping of any material in the lake. Fine \$1.00 per each offense.
 - b. no bathing with soap or washing articles in lake. Fine \$1.00.
- 6.) That stickers be placed on all beats and cars. Fine 1.00 per each offense.
- 7.) That a committee be formed to look into the possibility of a marina. This committee should consist of one front lot owner, one back lot owner, and a member of the beach and recreation committee.
- 8.) Before any plans are submitted to the members concerning the pavillion, the beach and recreation committee should have a chance to study and submit any changes or recommendations to the building committee.
- 9.) to drain the lake four feet to make repairs on beaches. This should be done every 2 years.

It was decided that these suggestions be set forth to the Board of Directors at their next meeting.

Mr. Gierula suggested that the executive committee get in touch with the Selectman of the Town of Lebanon to appoint constables from the lake to patrol during the summer. This will be submitted at the next Board of Directors meeting.

It was suggested that signs be posted on the roads ----Reflector curve signs and Watch for Children signs.

Three fence posts and 2-10' sections will be ordered and installed to repair the fences at the beaches. The fence on the entrance to the lake on Rt. 207 will be repaired again this year.

Mr. Gierula suggested that signs be posted in the water informing boats to slow down near the beaches and lots. It was decided that these be included in the rules on the bulletin boards.

A motion was made and seconded that Mrs. Mahoney and Mrs. Miller audit the books again this year.

Three members were appointed to the Nominating Committee. Bud Miller, Stanley Gierula, and Mrs. Martin.

Mr. Silva made a motion and it was seconded that the September meeting be changed to the 3rd Sunday of August due to the lack of attendance at this meeting.

Mr. Gierula reported for the Building Committee that Mr. Parker has a bid in for a pre-fab 26' x 32' building set on piers for the recreation area which would cost \$1800.

The meeting adjourned at 6:00 p.m.
